A) CONTRACT DOCUMENTS

1. Bid Form

<u>DELETE</u> the original Bid Form and <u>REPLACE</u> with the attached Bid Form which include the following changes:

• Add pay item "Re-Mobilization for Small Quantities, LS"

2. Scope and Specifications

Scope and Specifications are modified to add description, measurement, and payment for "Re-Mobilization, Small Quantities, LS."

A fixed cost of \$100 will be paid for each location where the quantity of work is less than four (4) hours of work and will be paid under the bid item "Re-mobilization, Small Quantities, LS." A location is defined as either one continuous street/neighborhood or one address/parcel. No remobilization costs will be paid for continuous street/neighborhood with a Task Order value greater than \$5,000.00.
